



Dear PARD/Keystone Members,

PAR D and our lobbyists made great strides in 2023! We forged relationships with IBX and Optum, which has directly helped lots of members. We met with the Shapiro Administration several times, as well as worked with key legislators to get SB1000 introduced. This will increase PBM transparency and help create fair contracts with MCOs in Medicaid for pharmacies and patients. We also met with the Auditor General and discussed the need for a deep study in the MCO program.

We have lots more work to do, as Community Pharmacy is at a crossroads. A healthy PhilPAC is necessary for this. If you are already a monthly or one-time contributor, thank you! If you are not, WE NEED YOU TO START CONTRIBUTING. Currently, we have only about 10% of the membership giving to PhilPAC.
